## AMERICAN INSTITUTE OF ARCHITECTS CENTRAL VALLEY CHAPTER

Among this year's acclaimed projects in the AIA Central Valley Design Awards program are out-of-the box public buildings, adaptive reuse residences and major aquatic infrastructure.

Dozens of entries were submitted into categories for built and unbuilt projects. And new this year, a Regional Recognition Award recognizes timeless or iconic architecture in the Central Valley built by both member and nonmember firms.

Awards were given in three tiers: honor, merit and citation.

With no required number of awards, jurors whittled entries down to nine award recipients. They recognized infill projects encouraging public transportation and live-work lofts in Oak Park, brownfield projects benefiting midtown Sacramento and sustainable design in Placerville.
